THIRTY-NINE FIRST-YEAR TEACHERS WERE GIVEN \$100 EACH TO SUPPORT THEIR CLASSROOM PREPERATOIN WITH A SUM OF \$3,900 PAID BY THE FOUNDATION. ADDITIONALLY, THE FOUNDAITON SUPPORTED THE DISTRICT'S ANNUAL BACK TO SCHOOL FAIR THAT PROVIDED BASIC SCHOOL SUPPLIES TO APPROXIMATELY 1,000 DISADVANTAGED WYLIE ISD STUDENTS.
